# What does COPIC do with your personal information?

#### WHAT?

The types of nonpublic personal information we collect can include:

- Medical History
- · Insurance Claim History
- · Employment Information
- · Account and Payment History

#### WHY?

All companies like COPIC need to share customers' personal information to transact everyday business. During day-to-day operations, we may share nonpublic personal information about you within COPIC affiliates for several reasons, including, to:

- Complete our underwriting process
- Obtain and provide risk management guidance
- · Fulfill transactions you have requested
- · Service your policy
- · Offer COPIC products to you
- · Investigate or handle claims

We may also share nonpublic personal information with nonaffiliates to:

- Detect or prevent fraud or comply with lawful requests from regulatory and law enforcement authorities
- Comply with federal and/or state laws relating to the reporting of judgments and/or settlements in medical liability actions
- Permit them to service your account(s) or perform support services on our behalf
- · Confirm eligibility for membership discounts and to carry-out joint marketing agreements

When you are no longer our customer, we continue to share your information as described in this Notice.

## WHAT WE DO

# How does COPIC protect my personal information?

To protect your nonpublic personal information from unauthorized access and use, we use security measures that comply with federal and state laws, and industry practices. These measures include electronic safeguards as well as secured facilities.

In addition:

- We do not sell any customer information
- We require persons or organizations providing services on our behalf to keep your information confidential.
- We require those persons or organizations to use your information only to provide the services we've asked them to perform
- We communicate to our employees about the need to protect nonpublic personal information about you
- We have established physical, electronic, and procedural safeguards to protect this information

## How does COPIC collect my personal information?

We collect data about you as we do business with you. Some of the sources of this data are as follows:

- Information you provide when you apply or enroll for products or services. You may provide data such as, medical license number or, when applicable, health history
- Information we obtain from others through our transactions and experience with you. This
  may include claim reports, medical records, credit reports and similar data
- Information we obtain through our transactions and experience with you. This includes your claims historyand payment records, as well as incident reports
- Information we obtain through our web site. This includes data from online forms you
  complete. It alsoincludes data we receive when you visit our web site

### **CAN I LIMIT ALL SHARING?**

Federal law gives you the right to limit the sharing of nonpublic personal information. However, COPIC does not share your nonpublic personal information outside of the COPIC affiliates with nonaffiliates except as described above.
