COPIC'S Three-Hour Opioids Review (Education for DEA Training Requirements)

This activity is specifically designed to cover topics in the DEA requirements around training on treatment and management of patients with opioid use disorder (OUD). This extensive course outlines the extent and some of the causes of the opioid crisis in the US. It additionally covers both office and prescriber roles in treating and managing patients with OUD including tapering protocols and appropriate clinical use of medically assisted treatment (MAT). The course also highlights the role of the interprofessional team in the management of their patients.

Objectives:

- Demonstrate an understanding of best practices around use of opioids and how to access and utilize CDC and other national organization recommendations for providing pain care.
- Discuss the history of the opioid crisis in the US and why it continues to be a leading cause of morbidity and mortality.
- Articulate measures to individualize pain management for a specific patient's pain type and anticipated duration of pharmaceutical interventions.
- Discuss common signs of OUD and articulate some methods of medically assisted treatment for management.

Opioid Management: A Practical Approach to a National Crisis (Opioids I)

This course focuses primarily on educating providers about the history and extent of the opioid crisis in the US and instructs prescribers about how to approach care to help reduce the crisis. It describes the regulatory guidance, indications, contraindications, best practice in usage of prescribing and managing opioids, and highlights the role of the interprofessional team in the management of their patients.

Objectives:

- Demonstrate an understanding of how to access and utilize CDC recommendations for clinicians providing pain care, including those prescribing opioids.
- Discuss the history of the opioid crisis in the US.
- Articulate measures to individualize pain management for a specific patient's pain type and anticipated duration.
- Discuss common signs of OUD.

Opioid Crisis: Strategies for Reducing the Burden (Opioids II)

This activity is complementary to other opioid courses, but it also stands alone in teaching about the current opioid crisis in the US and how to help compassionately and effectively care for patients on chronic opioids or with opioid use disorder (OUD). While addressing these issues, the course describes the regulatory guidance, indications, contraindications, best practice in usage of prescribing and managing opioids, and highlights the role of the interprofessional team in the management of their patients.

Objectives:

- Discuss the history of the opioid crisis in the US.
- Demonstrate an understanding of how to use opioids chronically.
- Discuss common signs of OUD.
- Describe what to do when you diagnose OUD.
