

THE LEGISLATIVE LANDSCAPE

COPIC FIGHTS FOR ACCESS TO SAFE, QUALITY HEALTH CARE DELIVERY

The General Assembly is near adjournment for the 2019 legislative session. There have been many health care bills this year aimed at addressing the cost of health care and other issues. As COPIC reviews the many health care related bills, it remains committed to monitoring and engaging on bills that impact access to care and the delivery of safe, quality care; a few of those are highlighted below.



SENATE BILL

193

SUNSET OF THE COLORADO MEDICAL PRACTICE ACT

The Colorado Medical Practice Act (MPA) Sunset bill proposes to reauthorize and extend the Act until 2026. The MPA established the Colorado Medical Board to regulate the practice of medicine and includes laws controlling the licensing and practice of physician assistants (PAs) and anesthesiology assistants (AAs) in addition to the licensing standards for medical doctors and doctors of osteopathy.



SENATE BILL

201

OPEN DISCUSSIONS ABOUT ADVERSE HEALTH CARE INCIDENTS

The bill establishes a Candor program, promoted by the U.S. Department of Health and Human Services' Agency for Healthcare Research and Quality, which allows for a new approach in dealing with unexpected outcomes that creates a voluntary alternative to the current tort system. This approach focuses on addressing patients' needs and may lead to a financial resolution in certain cases. Candor promotes open discussions, so patients and their loved ones can understand what happened and what steps may be taken to prevent similar outcomes. Maintaining a stable tort environment, protecting the MPA and PRA, and supporting programs like Candor are paramount issues for COPIC. Monitoring the final days of the legislature and keeping you informed on how these will impact you are COPIC's top priority. SENATE BILL

234

SUNSET OF THE COLORADO PROFESSIONAL REVIEW ACT

The Colorado Professional Review Act (CPRA) Sunset bill proposes to reauthorize and extend the Act until 2030. CPRA, which allows for the review of health care professionals' qualifications and competence, quality and appropriateness of patient care, or professional conduct, is up for review this session as part of a periodic review process. The legislature must pass legislation for CPRA to continue the protections for the reviews as well as the participants and those serving on the committee. CPRA requirements include:

- Registration with the Colorado Department of Regulatory Agencies (DORA) in order to receive the privileges;
- Annual reporting of aggregate peer review activities; and
- ▶ Updating of contact information.

At the time of publication of this newsletter, CPRA was still awaiting a hearing in the legislature.

2018 COPIC Humanitarian Award—Dr. Mark Paulsen

For nearly 30 years, Dr. Mark Paulsen, a family practice physician, has passionately committed his life and his work to the betterment of his community. He served as the volunteer medical director at Granby Ranch Ski Patrol and YMCA: Snow Mountain Ranch Ski Patrol donating his time to ensure that the first responders are well trained and that their protocols are clinically sound. Additionally, Dr. Paulsen volunteers with the Grand County Search and Rescue, as well as aiding surrounding communities by volunteering to help form coalitions of their own. For this, and many other reasons, he was chosen as the recipient of the 2018 COPIC Humanitarian Award in honor of Harold E. Williamson.



The Humanitarian Award recognizes a physician going above the call of duty in the Colorado health care community. Dr. Paulsen has volunteered as chief of staff, chief medical officer and, most recently, medical director at Kremmling Memorial Hospital District's clinics.

Dr. Mark Paulsen chose the Middle Park Medical Foundation as the beneficiary of the \$10,000 grant associated with the Award. The Middle Park Medical Foundation works to

improve health care in and around Kremmling, Colorado through donations, volunteerism, scholarships, and other charitable means.

In March 2019, Dr. Paulsen was recognized at the state capitol, where he was introduced before the Colorado General Assembly. He was accompanied by his wife, Heather, his sister, Susan Paulsen as well as Jason Bryan, executive director of the Middle Park Medical Foundation.

His nomination form noted, "Rural hospitals often have limited financial resources and these additional duties were regularly unpaid. He took on these duties without complaint to ensure the prosperity of the hospital district and that the quality of healthcare for [Grand County] was sustainable."

THE LEGISLATIVE LANDSCAPE

COPIC SUPPORTS MOVES TO EXPAND PATIENT SAFETY

The Unicameral has just over a month left of its 120-day legislative session. Over the last four months, COPIC has reviewed and supported legislation aimed at improving patient safety in the state. A few of those bills are highlighted below.



LEGISLATIVE BILL

19

The bill, passed unopposed by the Unicameral, provides for confidentiality of records and immunity from liability for professional health care service entities involved in peer review, including physician practices. The Health Care Quality Improvement Act (HCQIA) currently allows for these reviews in licensed health care facilities, and providers with privileges at these facilities. These facilities have utilized peer review committees to provide oversight and improve care delivery every day. This bill makes this learning through confidential reviews available to all professional health care service entities. COPIC is acutely aware of the patient safety improvements that result when a culture of reporting adverse outcomes and near misses for learning; where health care providers are encouraged to review their peers; and where lessons learned are shared with others exists. COPIC worked to support the bill proponents—the Nebraska Medical Association, and sponsor, Senator John Arch.



LEGISLATIVE BILL

489

The bill requires each credential holder under the Uniform Credentialing Act to register with the DHHS for the prescription drug monitoring system if the credential holder is a dispenser or prescriber. The DHHS shall establish a system of registration. The bill remains in committee.



LEGISLATIVE BILL

365

The bill creates the Health Care Directives Registry Act, which requires the Department of Health and Human Services (DHHS) to establish and maintain access to a secure portion of the DHHS website that provides an electronic reproduction of advance health care directives that can be retrieved from the website. Access to the website is only allowed to those who are registered with a password and access to the advance health care directive is:

- Required pursuant to a lawful court order;
- ► Requested by the registrant/legal representative;
- Requested by the Public Guardian;
- Requested by an EMS agency to provide medical care to the registrant; or
- Requested by a health care provider for providing health care to the registrant.

The bill creates some obligations on a provider who completes a copy of an advance health care directive to submit a copy of the directive if the patient/patient's decision-maker chooses to participate in the registry, however this burden is outweighed by the benefit of having ready access to the directives when needed to assist with treatment decisions. The bill remains in committee.

A GUIDE FOR LAW ENFORCEMENT INTERACTIONS

Health care providers may experience interactions with law enforcement personnel that create uncertainty around their responsibilities to patients, including the duty to protect patients' privacy. Law enforcement personnel are tasked with ensuring public safety and conducting criminal investigations. When these duties intersect as they relate to patients in the health care system, providers should understand how to meet their obligations while respecting the requests of law enforcement personnel.

COPIC recently released "Law Enforcement Interactions— Guidance for Health Care Providers in Nebraska," a booklet designed to help insureds understand and navigate these situations. The booklet covers how protected health information (PHI) and disclosures under HIPAA influence what providers should consider. It also provides details on mandatory reporting requirements under Nebraska laws for scenarios such as sexual assault, child abuse, and patient testing.
