Continuing Education That Can Earn You a **Premium Discount**



What is the COPIC Points Program?

This program was created to reward insureds who participate in COPIC's educational activities that include courses, seminars, and programs. Activities are developed by experts in our Patient Safety & Risk Management and Legal departments, and the content is designed to help address key areas of risk and current issues in health care. Not only do insureds gain valuable knowledge through these opportunities, but they also earn points that apply toward a premium discount. And many activities also qualify for CME credit.

Who can participate in the program?

Eligible COPIC-insured physicians, advanced practice providers, and facilities.

What are some activities that qualify for **COPIC** points?

- Take an on-demand course—Simply visit our site at www.callcopic.com/education; there are 60+ courses and most take around 30-45 minutes to complete.
- Attend the COPIC Forum (insured facilities)—This annual event is designed for staff at medical facilities and will be held in-person in Denver this year on October 6-8.
- **Complete a Practice Quality Review or Facility** Assessment—Overseen by experienced nurses, these reviews look at your practice's/facility's systems to identify potential areas of risk and help mitigate these with guidance on best practices and suggested improvements.

- Consider customized trainings—There may be opportunities to work with COPIC to develop a training that focuses on a particular issue that is relevant to your situation; if you are interested in scheduling a seminar at your facility or practice, please contact Carmenlita Byrd at cbyrd@copic.com or (800) 421-1834, ext. 6131.
- Earn points for programs offered by other organizations—COPIC will consider approving COPIC points for programs and seminars given by other organizations such as professional societies, medical societies, and hospital programs. These programs must be approved in advance and the decision is based on the patient safety and risk management content.

What are the other key details about the program?

- Points are earned during a one-year cycle that runs from January to December.
- Participants need to have a balance of 3 or more COPIC points at year-end in order to receive the premium discount on their subsequent year's policy renewal.
- Participants will be able to roll over excess points of those required in a given year and apply these to the subsequent year (up to a maximum of 6 points).
- Full- and part-time medical professionals will follow the same point system.

THE COPIC POINTS PROGRAM (FROM PAGE 1)

- New eligible physicians, advanced practice providers, and allied health professionals automatically receive the
 premium discount, but need to participate in the program during their first full calendar year of being COPIC-insured
 to maintain the discount for the subsequent year.
- Facilities: All facilities insured under COPIC's facility policy form are eligible. Points are earned on a one-year cycle (Jan.-Dec.), and policyholders can earn up to three points each year to receive the premium discount for the upcoming renewal cycle. There is no rollover provision of excess points from one year to another. Discounts earned are applied toward the premium charged for facility coverage at a policy level only. Discounts are subject to minimum premium requirements and do not apply to premium charged for individuals listed on the policy.

Please note: Due to COVID-19, COPIC awarded each eligible physician and advanced practice provider 3 COPIC points to recognize the additional steps necessary to provide safe care during the pandemic. In addition, we awarded each of our eligible insured facilities the Tier 1 (3%) discount to recognize their efforts as well. This was a one-time action for 2020, and as of 1/1/21, the COPIC Points Program resumed as normal.

REQUEST FOR GRANT FUNDING PROPOSALS

The COPIC Medical Foundation will kick off its next round of strategic responsive grantmaking in November 2021. Potential candidates for grants need to complete and submit a Request for Proposals (RFP). The RFP for the 2022 grant cycle will be due January 14, 2022.

Area of focus for grants: Grants awarded will be for initiatives that focus on reducing fragmentation across care settings. A top concern in the field of patient safety, breakdowns in care from a fragmented health care system can lead to readmissions, missed diagnoses, medication errors, delayed treatment, duplicative testing and procedures, and reduction in quality of care leading to general patient and provider dissatisfaction. Our goal with grants is to contribute to a solution that addresses this concern and supports scalable or replicable solutions, focuses on the testing of new ideas or growing existing solutions, and then looking for avenues for larger applications in health care.

To be considered for funding, organizations must meet the following minimum criteria:

- Approach or program has demonstrated potential for uptake and/or replication in the health care community.
- Organization is designated as a 501(c)(3) organization or has an identified fiduciary.

THE LEGISLATIVE LANDSCAPE

RECAP OF THE 2021 SESSION

The First Session of the 73rd Colorado Legislature adjourned on June 8. In total, 612 bills were introduced this session. Legislators took up a wide swath of ambitious initiatives this session including stricter marijuana regulation, gun control, unprecedented transportation funding, and the Colorado Public Option proposal.

Governor Jared Polis signed Colorado's \$34.1 billion 2021-22 budget into law in May, restoring cuts made during the coronavirus crisis last year and setting aside money for future economic downturns. COPIC's primary efforts this year were focused on defending Colorado's stable tort environment against legislation aimed at overturning or preempting court decisions. Our Public Affairs team engaged on a number of bills dealing with perinatal health and delivery, tort reform, prescription drug monitoring, and licensure credentialing and sunsets.

With federal dollars expected to flow into Colorado, the legislature plans to set up interim working groups to consider how best to appropriate these funds. There is still a chance that a special session will be called later in the summer. A few of the health care-related bills COPIC monitored and engaged on this year are highlighted below. These bills have passed the general assembly and were either signed by the Governor or are awaiting a final signature (unless otherwise noted).



HB21-1005

Health Care Services Reserve Corps Task Force. This bill creates the health care services reserve corps task force in the Colorado Department of Public Health and Environment. The purpose of the task force is to evaluate and make recommendations on the creation of a health care services reserve corps program, in which medical professionals could cross-train to be able to serve the state in an emergency or disaster and receive student loan relief for their service.



HB21-1012

Expand Prescription Drug Monitoring Program (PDMP). This bill, as amended, grants the State Board of Pharmacy the authority via rulemaking to determine if the PDMP should track all prescription drugs in the state. If the Board determines that one or more prescription drugs should not be reported through the PDMP, the Board is required to make public the justification for the exclusion.



HB21-1188

Additional Liability Under Respondeat Superior. This bill seeks to overturn the Colorado Supreme Court's Ferrer ruling which adopted the McHaffie rule. The bill allows plaintiffs to sue not only a negligent employee, but will allow them to sue the employer for both vicarious liability for the acts of their employee and for derivative claims against the employer.



HB21-1232

Standardized Health Benefit Plan Colorado Option. This is the Colorado Public Option proposal. The bill, as amended, gives the health care industry three years to reduce health insurance premiums by 15% (based on 2021 rates) in the individual and small group markets. If the premium reduction targets are not met by 2025, the bill would require the state to create a standard health insurance plan that carriers would be required to offer. The newly created insurance plan would include price caps on health care services provided by hospitals and doctors. The final bill language removed the mandatory participation for doctors and removed the ability to revoke hospital licensure as a means of enforcing mandatory participation by hospitals.



HB21-1251

Appropriate Use of Chemical Restraints on a Person. This bill aims to limit the use of ketamine in a non-hospital setting.



SB21-126

Timely Credentialing of Physicians by Insurers. This bill aims to expedite licensure credentialing for providers in Colorado.

SB21-193 AND SB21-194

A pair of bills aimed at improving perinatal care in non-clinical settings and aligning Colorado Medicaid with federal Medicaid expansion covering postpartum care. The bills contained a wide range of mandates and policy changes on accepting patient transfers from non-clinical care providers, providing payment parity for all providers providing labor and delivery care, and mandating medical professional liability insurance carriers to cover vaginal birth after cesarean (VBAC) care. However, COPIC, along with many health care partners, worked with the bill sponsors to remove the mandates and address our patient safety concerns.



SB21-061

Claims for Economic Damages Incurred by Minors. The bill sought to change current law that permits only parents or guardians to seek pre-majority medical expenses for an injury to a minor. The bill would have allowed a minor to bring a cause of action for injuries caused by another as well as extend the statute of limitations.

Status: This bill was laid over until the end of session and will not be considered further this year.

- SB21-092: Sunset Surgical Assistants and Surgical Technologists.
- SB21-093: Sunset Continue Healthcare Infections Advisory Committee.
- SB21-094: Sunset Continue State Board of Pharmacy.
- SB21-097: Sunset Continue Medical Transparency Act.
- SB21-098: Sunset Prescription Drug Monitoring Program.
- SB21-101: Sunset Direct-entry Midwives.

COPIC's Public Affairs team worked alongside our partners at the Colorado Medical Society and the Colorado Hospital Association to monitor health care legislation that will impact your ability to deliver safe, quality care. Focus now turns from following the legislature to monitoring and engaging on the rulemaking stakeholder process. 

THE LEGISLATIVE LANDSCAPE

RECAP OF THE 2021 SESSION

The First Session of the 107th Nebraska Legislature adjourned on Thursday, May 27. In total, 684 bills were introduced during the first year of the two-year session. Bills that were not passed or voted down this year will carry over to the next regular legislative session, which begins January 5, 2022. A few of the health care-related bills COPIC monitored and engaged on this session are highlighted below:

LEGISLATIVE BILL 139

This bill adopts the COVID-19 Liability Act and the Health Care Crisis Protocol Act. This Act was approved by the Governor on May 25, 2021.

Under the COVID-19 Liability Act, a person may not bring a civil action for damages from exposure to COVID-19 for an act or omission that was in substantial compliance with any federal public health guidance that was applicable at the time. This only applies to acts or omissions on or after the effective date of the Act (5/25/21).

The Health Care Crisis Protocol Act references the "Health Care Crisis Protocol for the State of Nebraska" published by the Nebraska Medical Emergency Operations Center, dated May 10, 2021. If a health care facility is no longer able to provide the usual standard of care when the demand for medical services

exceeds supply as the result of a pervasive or catastrophic disaster, it may activate the health care crisis protocol.

LEGISLATIVE BILL 390

This bill would allow holders of medical licenses from other states to more easily receive a license to practice in Nebraska. It applies to certain health care professions that are regulated by Nebraska's Uniform Credentialing Act. This bill was approved by the governor on April 21, 2021.

LEGISLATIVE BILL 4U

LB 400 amends the Nebraska Telehealth Act, which applies to the Medicaid program, to expand the definition of "telehealth" to include audio-only services for the delivery of behavioral health services. This bill was approved by the governor on April 21, 2021.

LEGISLATIVE BILL 411

LB 411 requires the sharing of information with the designated health information exchange (HIE). This bill aims to require health care facilities to participate in and provide clinical information to the state-sponsored HIE. This bill was approved by the Governor on May 24, 2021.

LEGISLATIVE BILL 583

This bill requires electronic prescriptions for controlled substances. The bill mandates electronic prescribing for controlled substances beginning January 1, 2022 and provides for exceptions. This bill was approved by the Governor on May 5, 2021.

CARRY-OVER LEGISLATION

(Not Passed or Voted Down)

LEGISLATIVE BILL 160

LB 160 would change provisions of the Nebraska Hospital-Medical Liability Act. The bill aimed to increase the existing medical liability caps and the underlying fund limits. The bill was tabled for consideration until next session.

OTHER LEGISLATIVE NEWS

This month was also the deadline for interim study resolutions to be introduced. These studies tend to highlight a legislator's interest in an issue or send a signal that legislation might be introduced next session. COPIC is following the introduced study topics, particularly Legislative Resolution 200. The purpose of LR 200 is to examine the long-term fiscal sustainability of the Nebraska Health Care Cash Fund.

The study will provide recommendations for any statutory or funding changes that the legislature should make in order to protect the ongoing viability of the fund which provides vital funding for more than 20 government programs including children's health insurance, aid for people with developmental disabilities, compulsive gambling assistance, and biomedical research.

COPIC will continue to work closely with our partners at the Nebraska Medical Association to track the implementation of passed legislation and develop education on how these policies will impact your practice. THE LEGISLATIVE LANDSCAPE

RECAP OF THE 2021 SESSION

The lowa Legislature adjourned on Wednesday, May 19 after legislators extended the session by three weeks as they worked to finalize remaining priorities. In the end, the bill that aimed to harden the medical liability non-economic damages cap did not pass, nor was it included in the final standings bill—the last omnibus bill to be considered this session. COPIC will continue to navigate conversations and next steps with our health care and legislative partners in the coming months. A few of the health care-related bills that COPIC engaged on this session include:

PASSED LEGISLATION -

SENATE FILE 619

Senate File 619 is an omnibus tax bill that incorporates language from House File 893, which includes language providing mental telehealth payment parity (see Division 13 in the bill).

HOUSE FILE 891

House File 891 is a Health and Human Services Appropriations bill that incorporates amended language from House File 852, which allows a sponsor of a medical residency program of an lowa-based private or public hospital or affiliated nonprofit organization funding the payment of liability costs to receive state dollar-for-dollar matching funds to support the program, subject to a percentage of the state matching funds available each year (See Division 17 in the bill).

POSTPONED LEGISLATION

HOUSE FILE

House File 117 is a bill relating to the licensure of ambulatory surgical centers, providing for fees to be considered repayment receipts, and providing penalties.

HOUSE FILE 592

House File 592 relates to non-economic damage awards against health care providers.

HOUSE FILE 764

House File 764 is a bill relating to disciplinary hearings conducted by professional licensing boards.

SENATE FILE 557

Senate File 557 is the Senate companion bill to House File 592, relating to non-economic damage awards against health care providers.

COPIC will continue to work with our partners at the lowa Medical Society to track implementation of passed legislation and develop education on how these policies may impact your practice. Spencer has designated Primary




