



2022 COPIC Medical Foundation Grant Recipients Announced



We're thrilled to announce that the COPIC Medical Foundation has awarded \$680,000 in grants to five organizations focused on reducing fragmentation in the health care system. Congratulations to the following organizations:

>>Bryan Health Connect (Nebraska)

Funding will support a project to expand the Bamboo Health clinical event notification system to additional locations across Nebraska.

>>Children's Hospital Colorado (Colorado)

The grant will be used for the rollout and implementation of the ImPACT Navigation Hub in care coordination for complex pediatric patients as they transition to adult care.

>>Minnesota Medical Association Foundation (Minnesota)

Funding will be used for Project ECHO, which focuses on the challenge of transitioning youth with medical complexity to adult care in Minnesota.

>>Providence Portland Medical Foundation (Oregon)

The grant will help a partnership between Providence and the Oregon Physician Orders for Life Sustaining Treatment (POLST) Registry to build a bi-directional interface which integrates Providence's Epic electronic health record with the Registry.

>>West Mountain Regional Health Alliance (Colorado)

Funding will support Community Resource Network West Mountain, a social information exchange platform in western Colorado that facilitates care coordination for individuals experiencing homelessness with coordination by hospitals, health and behavioral health providers, community organizations, and government agencies.

8 WAYS TO PROTECT AGAINST RANSOMWARE

Ransomware is a type of malware (malicious software) that “kidnaps” your business data and holds it hostage until you pay a ransom. If you don’t pay the ransom, you lose your data, one way or another. Our cyber liability partners at Tokio Marine have highlighted eight ways to proactively address ransomware:

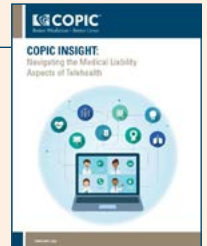
- 1 Train employees**—It sounds easy, but employees must never click on “bad links” or “bad attachments.” Learning to tell the difference requires training.
- 2 Remote Desktop Protocol (RDP) and access control**—50% of ransomware attacks are caused by poor RDP security. Therefore, properly securing RDP is essential. Also, ransomware will only encrypt files it can access so appropriately configuring access controls will help.
- 3 Install software patches**—Ransomware often finds “open gaps” in software to inject the poison. Patch software quickly to close the gaps and protect your assets.
- 4 Create offline backups**—Backups (clean, no ransomware) can save you. If you don’t pay the ransom or pay it but don’t receive the decryption key, a backup is the way to recover your data.
- 5 Implement two-factor authentication**—This protects your organization because it adds another layer of protection to password-protected remote access to your email.
- 6 Install and update “Next-Gen” antivirus**—Top-notch anti-virus programs hunt for new ransomware and other malware strains, then update their software to protect you.
- 7 Email security settings**—Social engineering attacks are very effective in facilitating a ransomware attack. Email security gateways are a key protective technology, and when properly configured, these technologies will assess and prevent most malicious emails and attachments.
- 8 Endpoint security**—If ransomware makes it through network defenses, endpoints are exposed. The endpoint is the gateway to all other network resources and data. To minimize the risk of the endpoint: remove local administrator rights from all employees and install (or activate) a recommended endpoint security program.

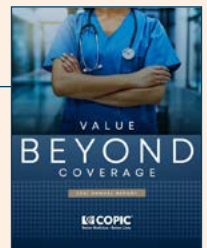

Then there are the people who are pillars of these principles, and we'd like to recognize one of these individuals as he prepares to retire—Steve Rubin.

After serving as COPIC's President for the past 21 years, Steve will retire on June 30, 2022. Steve's influence on the company will continue to be with us long after his departure as we remember his humble demeanor, sharp business mind, smart sense of humor, and unwavering commitment to insureds, employees, and the community.

"COPIC has focused on helping medical providers deal with the challenges in delivering patient care. That's important, significant, and it matters," said Rubin. "I've enjoyed my time at COPIC and being surrounded by people who believed in what they were doing and brought a passion to their work. Steve joined COPIC in 2000 after decades of executive experience in the areas of financial management, operations, and strategic planning. Prior to COPIC, he served as President and Chief Executive Officer of FirstCity Financial, and CEO and part owner of MortgagePlus, a Denver-based national mortgage company. He graduated with a bachelor's degree from Bowling Green University and received his master's degree in Finance from Northwestern University's Kellogg Graduate School of Management.

Steve's background before COPIC didn't involve insurance or health care, and this allowed him to bring a fresh, business-minded perspective to the company along with a different lens with which to

examine the fundamentals of medical liability insurance. From day one, he immersed himself in learning about all aspects of the business and retained his inquisitive approach over the years.

"Steve asks the questions that need to be asked. His ability to see past the nuances was crucial for COPIC. He opened my perspective to better understand the business and was a great mentor who allowed others to shine," said Sean Gelsey, COPIC's Senior Vice President of Claims & Strategic Partnerships.

HARRIS FRANKEL, M.D.

Dr. Frankel is a native of Omaha, Nebraska with over three decades of leadership experience in physician practice, hospital, and health system settings. He is the Chief Medical Officer (CMO) and Chief Compliance Officer for Nebraska Medicine, an Associate Professor in the Department of Neurological Sciences for University of Nebraska Medical Center, and maintains an active patient practice.

As CMO at Nebraska Medicine, Dr. Frankel serves as a resource to both administration and providers, working diligently to ensure the diverse interests of Nebraska Medicine's 1,000+ member medical staff is represented in health system initiatives and decisions. Quality Forum's Disparities Standing Committee, the Center for Medicare and Medicaid Services (CMS) committee to integrate equity measurement into payment and delivery models and is the Chair of the Board for the Colorado Health Institute. She also serves on the editorial boards of the journals *Health Affairs* and *Health Services Research*.

THE LEGISLATIVE LANDSCAPE

HIGHLIGHTS FROM THE 2022 SESSION

During the final weeks of March and early April, the Colorado General Assembly debated a \$36 billion state budget proposal. The fiscal year 2022-23 budget, which will go into effect July 1, is roughly \$2 billion larger than the state's current budget. More than 550 bills were introduced this session with more expected to come. With the state budget finalized, the pace of the session is expected to pick up in the coming weeks as adjournment draws near. The General Assembly is expected to adjourn on May 11 when the focus will shift to the Primary Election season. Colorado's Primary Election Day will be held on Tuesday, June 28.

POLICY AREAS WE ARE MONITORING IN 2022



HOUSE BILL 1050

International Medical Graduate Integrate Health Care Workforce: This bill includes a call from the Nurse-Physician Advisory Task Force for Colorado Healthcare (NPATCH) for the creation of the International Medical Graduate (IMG) Assistance Program. The program would streamline the process for international medical graduates to obtain licensure in Colorado.

a prescriber to designate an unlimited number of designees and creates a process for vendor selection and reimbursement payments for the integration of the PDMP into EMRs.



SENATE BILL 27

Prescription Drug Monitoring Program: A bill adopting DORA recommendations stemming from a state audit report conducted in 2021. The recommendations include stricter querying requirements on benzodiazepines, clarifying registration requirements and enhancing enforcement for health care providers.



HOUSE BILL 1272

Repeal of Attorney Fees on Motions to Dismiss: This bill aimed to repeal a provision that awards a defendant attorney fees in a tort action when the case is dismissed by the defendant prior to trial. It was amended in the House to preserve the protections for defendants while adding language to clarify existing rights for plaintiffs.



HOUSE BILL 1256

Modifications to Civil Involuntary Commitment: This bill seeks to reform the M-1 hold and 72-hour treatment and evaluation process in Colorado by placing new requirements on all emergency medical service facilities and staff that currently only apply to designated mental health facilities. COPIC is engaged in these discussions and will work with our partners to reduce the significant burdens this bill would place on emergency departments and emergency department health care providers.



HOUSE BILL 1115

Prescription Drug Monitoring Program (PDMP): This bill, similar to Senate Bill 27, clarifies a requirement that all prescribers must query the PDMP for every fill of an opioid or benzodiazepine and maintain an active user account within the PDMP. It also allows

COPIC PEER REVIEW NETWORK

CONNECT WITH AVAILABLE PROVIDERS TO SUPPORT PROFESSIONAL REVIEW SERVICES

COPIC understands that many of our insured facilities and practices face challenges in obtaining professional review services because of the small number of providers in certain specialties, possible conflicts of interest with providers reviewing partners or competitors, and high costs associated with third party review services. Therefore, we developed an alternative for our insureds, the COPIC Peer Review Network (CPRN).

CPRN offers a pool of providers identified by each participating policyholder to facilitate professional review in a wide range of specialties. **This is a voluntary opportunity and there is no cost to join the network.** Our aim is to establish a network of providers who will act as a resource in performing external professional review services for other participating policyholders. This opportunity provides a solution to an identified need and, more importantly, a mechanism to collaborate in improving quality care.

Participating policyholders will need to:

- Complete a participation agreement.
- Verify to COPIC that it has peer review policies and procedures in place.
- You must be registered as a peer review organization with the Division of Professions and Occupations (DORA) in order to participate.
- After discussion with physicians and advanced practice nurses (APRNs), access the network to add the initial list of physician specialties and APRN scopes of practice represented by your providers available to provide professional review services to other facilities and practices insured by COPIC.
- Maintain the listing of specialties and APRN classifications along with your participation status and contact information on the COPIC website.
- Upon request from another participating policyholder, provide the contact information for physicians and/or APRNs who have agreed to provide services.

COLORADO COPIC HUMANITARIAN AWARD—DR. TED NING

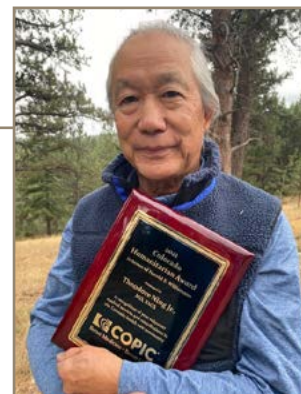
Dr. Ted Ning is a successful urologist who decided to leave his practice at the age of 50 to follow his heart and passion to help others. As a founding and participatory member in a variety of nonprofit organizations, the local and international community has been significantly impacted by Dr. Ning's vision, strategy, and commitment to addressing social issues.

Beginning in residency, Dr. Ning spent countless volunteer hours working at the Denver Free Clinic and with Operation Babylift, a program to care for orphans evacuated from Vietnam as the war ended. After residency, he continued his volunteer efforts by implementing and growing numerous nonprofit organizations. Throughout the years, Dr. Ning has volunteered his time in causes that empower women in impoverished countries like Guatemala and Vietnam.

Additionally, Dr. Ning has served as the Founding Board President for Resilience1220 which provides free counseling services to youth ages 12-20 in the mountain communities west of Denver. Through counseling, support

groups, and community outreach, Resilience1220 works to raise awareness of the social, emotional, and mental health issues young adults face, and to provide the necessary life skills to create wellness and resiliency in their lives.

The list of Dr. Ning's volunteer activities, contributions, and recognitions is extensive. For these and many other reasons, COPIC and the Colorado Medical Society have selected him as the honoree for the 2021 COPIC Humanitarian Award. Dr. Ning has chosen Resilience1220 as the beneficiary of the \$10,000 donation associated with the award.





THE LEGISLATIVE LANDSCAPE

HIGHLIGHTS FROM THE 2022 SESSION

COPIC has long believed that taking an active role in advocating on legislative issues is an important way to allow the health care community to devote its resources to quality improvement and patient care. COPIC monitors regulation and legislation in Nebraska to ensure that access to safe, quality health care delivery is maintained, and new, unreasonable burdens are not placed on health care providers.

By working closely with the Nebraska Medical Association, COPIC tracks legislation using the lens of stabilizing the tort environment, promoting learning in health care, ensuring the delivery of safe, quality care, and protecting the patient and physician relationship. During the final days of the session, the Unicameral prioritized a few remaining measures, including finalizing the state budget and allocating the \$1 billion in American Rescue Plan Act (ARPA) funds. The Unicameral adjourned on April 20 and the focus now shifts to the Primary election season. Nebraska's Primary Election will be held on Tuesday, May 10. March 1 was the final deadline for candidates to file to run for elected office this year. Twelve candidates filed to run for governor. Further, 24 of Nebraska's 49 legislative seats are up for election in 2022. Below is a list of bills COPIC monitored this session:



LEGISLATIVE BILL 697

This bill creates language around the licensure of rural emergency hospitals and services provided. The bill allows current Critical Access Hospitals and rural Prospective Payment System hospitals with fewer than 50 beds to convert to Rural Emergency Hospital status in order to furnish certain outpatient hospital services in rural areas, including emergency department and observation services. This measure is supported by the Nebraska Hospital Association.



AMERICAN RESCUE PLAN ACT (ARPA) FUNDING

Legislative Bill 1014: This bill appropriates federal funds allocated to the State of Nebraska pursuant to the federal American Rescue Plan Act of 2021. This omnibus ARPA appropriations bill houses language from the following measures:

- ➔ **Legislative Bill 1066:** This bill appropriates ARPA funds to DHHS and the University of Nebraska for behavioral health care services.
- ➔ **Legislative Bill 1075:** This bill appropriates ARPA funds to DHHS for technology that will support statewide pediatric mental health services.
- ➔ **Legislative Bill 1089:** This bill appropriates ARPA funds to DHHS for licensed and Medicaid-certified nursing facilities.

CONNECT WITH AVAILABLE PROVIDERS TO SUPPORT PROFESSIONAL REVIEW SERVICES

COPIC understands that many of our insured facilities and practices face challenges in obtaining professional review services because of the small number of providers in certain specialties, possible conflicts of interest with providers reviewing partners or competitors, and high costs associated with third party review services. Therefore, we developed an alternative for our insureds, the COPIC Peer Review Network (CPRN).

CPRN offers a pool of providers identified by each participating policyholder to facilitate professional review in a wide range of specialties. **This is a voluntary opportunity and there is no cost to join the network.** Our aim is to establish a network of providers who will act as a resource in performing external professional review services for other participating policyholders. This opportunity provides a solution to an identified need and, more importantly, a mechanism to collaborate in improving quality care.

Participating policyholders will need to:

- Complete a participation agreement.
- Verify to COPIC that it has peer review policies and procedures in place.
- After discussion with physicians and advanced practice nurses (APRNs), access the network to add the initial list of physician specialties and APRN scopes of practice represented by your providers available to provide professional review services to other facilities and practices insured by COPIC.
- Maintain the listing of specialties and APRN classifications along with your participation status and contact information on the COPIC website.
- Upon request from another participating policyholder, provide the contact information for physicians and/or APRNs who have agreed to provide services.

THE LEGISLATIVE LANDSCAPE

HIGHLIGHTS FROM THE 2022 SESSION

COPIC has long believed that taking an active role in advocating on legislative issues is an important way to allow the health care community to devote its resources to quality improvement and patient care. COPIC monitors regulation and legislation in Iowa to ensure that access to safe, quality health care delivery is maintained, and new, unreasonable burdens are not placed on health care providers.

By working closely with our colleagues at the Iowa Medical Society, COPIC tracks legislation using the lens of stabilizing the tort environment, promoting learning in health care, ensuring the delivery of safe, quality care, and protecting the patient and physician relationship. Since the Iowa Legislature convened in January, COPIC's focus, along with our colleagues at the Iowa Medical Society, has primarily been on advancing a priority measure of Governor Kim Reynolds that includes a hard cap on noneconomic damages in medical liability cases. The bill, Senate File 2275 listed below, aims to set a hard cap for noneconomic damages at \$1 million. As of the writing of this publication, the Senate version has passed out of committee and is awaiting further action. Legislators have an incentive to wrap up their work for the year with primary election season looming. The filing deadline for candidates to run for state office was March 18, 2022. Iowa's Primary Election will be held on June 7, 2022.

POLICY AREAS WE ARE MONITORING IN 2022



HOUSE FILE 2248

This bill requires a health care provider who determines that a patient is a candidate for outpatient surgery and refers the patient to an ambulatory surgical center, to provide the patient with a written document listing the factors the patient should consider in order to make a fully informed decision about the patient's recommended course of care.



HOUSE FILE 2388

This bill creates a new Code chapter to provide for the licensing and regulation of ambulatory surgical centers. The bill prohibits the establishment, operation, or maintenance of an ambulatory surgical center in the state without obtaining a license.



HOUSE FILE 803

This is a carry-over bill from the 2021 session that expands duties that can be performed by physician assistants to include, by statute, duties that currently can only be performed by a physician. The bill does not remove the requirement for PAs to be supervised by a physician.



SENATE FILE 2275

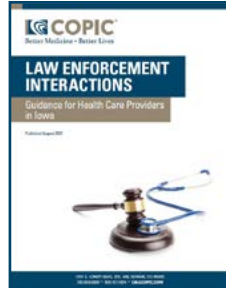
This bill is a measure that includes language creating a hard cap on medical liability noneconomic damages at \$1 million. This was a companion bill to HF 2279 which was amended in the House to remove the cap, but the bill failed to pass a vote on the House floor.

>>Law Enforcement Interactions

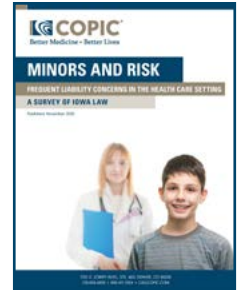
